

The Black Sea NGO Forum continues to be a driver of change

The Black Sea NGO Forum is an annual regional event first organised in 2008 by the Romanian NGDO Platform (FOND) in the context of the Black Sea Synergy European Policy, with the support of the Romanian Ministry of Foreign Affairs, the Representation of the European Commission in Romania and the Black Sea Trust for Regional Cooperation. Since 2013, the Forum has been financially supported by the European Commission. Its main objectives are to increase the level of dialogue and cooperation among NGOs in the wider Black Sea Region, to strengthen the capacities of NGOs to influence regional and national policies and to increase the number and quality of regional partnerships and projects.

Since its very first edition, the Black Sea NGO Forum enabled an **open space for debate, sharing mutual knowledge and understanding, communication and cooperation** among civil society representatives, governments, international organisations and donors active in the Black Sea region. The Forum focuses on **sharing good practices** in various domains and **success stories of regional cooperation**.

More than 13 years after, the Black Sea NGO Forum has become a driver of change in the region, reuniting more than 1,300 participants from 11 countries: Armenia, Azerbaijan, Belarus, Bulgaria, Georgia, Greece, the Republic of Moldova, Romania, Russia, Turkey and Ukraine. The Forum has enabled participants to share expertise and best practices on a diversity of themes of regional interest (democracy & human rights; local development; youth; children rights; environment; sustainable development, citizen participation etc.), encouraged multi-stakeholder dialogue and facilitated partnerships, thus, contributing to building trust and joint projects, identifying common challenges and opportunities and addressing them together.

In 2019, the Romanian NGDO Platform – FOND started the implementation of the project "Building CSO Capacity for Regional Cooperation within the Black Sea Region" with the financial support of the European Union for the period 2019 – 2021. The project aims at increasing stability and prosperity in the Black Sea Region by strengthening regional



cooperation among CSOs in the region, in the context of sustainable development and societal resilience.

The 13th edition of the Black Sea NGO Forum: Advancing Civil Society Cooperation in the Black Sea Region in Times of Uncertainty

The 13^{th} edition of the Black Sea NGO Forum: Advancing Civil Society Cooperation in the Black Sea Region in Times of Uncertainty has been organized between the 23^{rd} – 27^{th} of November 2020, in an online format.

The event was organized by the Romanian NGDO Platform – FOND, with the financial support of the European Commission and in partnership with the Romanian Ministry of Foreign Affairs.

In the context of the Sars-CoV-2 pandemic, the 2020 edition of the Black Sea NGO Forum, through its unique format, aimed to contribute to identifying the common challenges that the civil society organizations and facing, as well as opportunities for addressing them together, with specific focus on:

- Raising awareness on success stories of CSOs in the Region during the COVID-19 pandemic;
- Showcasing donors' response for supporting CSO development and resilience in this new challenging context;
- Presenting the progress made and next steps for the implementation of European Union's policies in the Black Sea Region;
- Creating a space for debate on Enabling Environment for civil society organizations in the Black Sea Region in the first half of 2020;
- Strengthening the importance of engaging in regional multi-stakeholder cooperation, with an emphasis on best practices and lessons learned on developing and consolidation civil society public private sectors partnerships.
- Highlighting the main achievements and future strategic actions of the Black Sea NGO Forum in fostering regional cooperation, through the project "Building CSO Capacity for Regional Cooperation within the Black Sea Region", funded by the European Union.

Key points:


- Civil society organizations in the Black Sea Region represent a reliant partner in elaborating and implementing public policies for addressing the COVID-19 pandemic at national and regional levels;
- The new context has impacted not only civil society representatives in their work, but also beneficiaries, and there is a strong need of identifying ways for reconstructing trust and interaction;

 The new context has exposed internal vulnerabilities, but created opportunities for fostering solidarity, support and dialogue among CSO representatives and relevant stakeholders.

In the new context created by the Sars-CoV-2 pandemic, states and societies around the globe have been highly affected, being forced to find new ways of functioning and strategies for adapting to the new reality.

According to the findings of the Policy Paper on "The Impact of the COVID-19 Pandemic on the Civil Society Sector in the Black Sea Region" (July 2020), developed by the Romanian NGDO Platform – FOND, during the COVID-19 pandemic, non-governmental organisations from the Black Sea Region (both EU and non-EU countries) have been facing similar challenges on internal and external levels, proving at the same time to be relevant and reliant partners for national institutional actors, becoming more involved in regional dialogue and cooperation, despite incoherent or restrictive legislative and financial environments.

As most of other sectors of the societies, a great part of civil society work has been restricted to online formats, blurring the divide from work to one's



personal life and putting great pressures on a faster adaptation process. The longevity of the pandemic and the ongoing restrictions have affected not only civil society representatives in their work, but also beneficiaries, marginalizing even more the already marginalized communities. These new frameworks imposed limitations of civil rights and liberties, along with increasing economic insecurity, creating gaps in interaction and limiting the impact of CSO activities at grass-roots levels. CSO representatives must identify new innovative approaches for making their work more relevant and more interactive than ever.

Civil society organizations have been confronted with situations and challenges never encountered before, **exposing internal vulnerabilities** and at the same time, **capabilities to unite** against the new climate caused by the pandemic. These difficult times underwent by civil society organizations also provided an **opportunity to evaluate and rethink strategic long-term priorities**, clarifying their positioning in relation to national governments, partners and donor organizations. In this new context, non-governmental representatives stressed the importance of the respect of fundamental rights and freedoms for the citizens, launching a **call for solidarity** among CSOs and **call for support** from national authorities, to facilitate them in reaching out to beneficiaries from less developed regions.

Key points:

- Increasing dialogue and building partnerships with CSOs are key for coordinating efficient approaches and solutions to the COVID-19 pandemic in the Black Sea Region;
- It is vital to deepen existing partnerships and prepare for the future, by investing in developing adapative resilience, to be able to carry on and withstand future potential shocks together;
- The European Union is reiterating its concrete support for civil society organizations, providing support of 1 billion EUR to the Eastern Neighbourhood and for advancing civil society organizations's work;
- o It is time to work together to build positive momentum on the EU green recoveryoriented commitments in the Black Sea Region, with a focus on blue growth and environmental protection cooperation;
- The new context provides an opportunity to rethink in a more sinergic dynamic, especially in the context of the Common Maritime Agenda, for the implementation of regional sectoral actions regarding the concept of blue economy.

The Coronavirus pandemic has posed to all societies serious challenges that require fast and efficient adaptation, in order to support economic cooperation, stability and prosperity. All the initiatives implemented by regional actors in what regards addressing the COVID-19 crisis in the Black Sea Region are important achievements that contribute to advancing cooperation. Despite this, there is still much to be done to effectively respond to the pandemic. All Black Sea Economic Cooperation Organization (BSEC) Member States are committed to enhancing cooperation and coordination for more efficiency-driven results. Thus, increasing constructive dialogue with other actors, including civil society organizations, is vital in these uncertain times. The work of the CSO sector, a positive force for change, can substantially complement BSEC activities.

National actors also express their openness and support for the increasing collaboration with civil society organizations, with a view to advance the implementation of the EU regional policies, with a focus on the Black Sea Synergy, the Common Maritime Agenda for the Black Sea and the Black Sea Startegic Agenda for Research and Innovation (SRIA). In the context of the COVID-19 pandemic and the newly crisis caused, an important milestone to be reached will be the EU Multiannual Financial Framework, which provides CSO from partner countries an opportunity to be involved in future negotations. Now it is the time to deepen partnerships, to reflect on how to advance together and how to invest in adapative resilience.

The European Union is also reiterating its concrete support for civil society organizations in these difficult times, attributing importance to their direct engagement in processes of combating the negative consequences of pandemic, mobilizing resources and preparing for the recovery processes. The newly launched EU Global Response to the COVID-19 pandemic paves the way forward for initiatives and collaboration. In a broader picture, in 2020, the EU, together with the European Investment Bank, has provided 20 billion EUR for the response in addressing the pandemic, out of which almost 1 billion EUR has been

secured for the Eastern Neighbourhood. The EU has given very important contributions for **increasing the resilience of partner countries** through budget support, which has contributed to the financial survival in a year where most of governmental revenues are decreasing.

Nevertheless, the EU is recognizing the CSO activity on ground as key in contributing to the mitigatation of the effects of pandemic and combating disinformation campaigns. The multifacetedd impact of the Coronavirus pandemic highlights the need to multilateral and multi-stakeholder approaches in the Black Sea Region, remaining committed to fostering stability, prosperity and sustainability. 2020 is also the time to work together to build positive momentum on the EU green recovery-oriented commitments. In the context of the region, this links to blue growth and environmental protection cooperation, in order to ensure a bottom-up holistic engagement.

The EU policy on blue economy makes no exception to the process of transformation underwent at the European level. The new context provides an opportunity to rethink in a more sinergic dynamic, especially in the context of the Common Maritime Agenda. In the first half of 2021, the European Commission will publish a new communication on new approach of **sustainable blue economy**, as an integral part of the European Green Deal. Blue economy is thus a key dimension for fostering regional cooperation, and a central element in foresighting policy making and implementation, as a response to the pandemic.

Key points:

- The COVID-19 pandemic context has created unique opportunities for CSOs to change and transform, embracing and putting into practice the concept of "resilience";
- CSO cooperation, through sharing of knowledge and expertise, and consolidated partnerships, is instrumental in the development of inclusive, resilient and adaptive societies in the Black Sea Region.

In 2020, civil society organisations have been pushed out of their comfort zones, for adapting to the new realities. Despite this, the new framework for functioning has created unique opportunities to change and transform, embracing the word and the concept of "resilience". The activities planned in the context of the project "Building CSO Capacity for Regional Cooperation in the Black Sea Region", implemented by the Romanian NGDO Platform – FOND, with the financial support of the European Union and of the Black Sea Trust for Regional Cooperation, a program of the German Marshall Fund, have focused exactly on these pressing NGO needs.



The COVID-19 crisis, for many of the CSO representatives, has been a learning invitation to reconsider ways of doing things, especially at the internal level. The Mobility Fund for CSO representatives within the Black Sea Region has provided opportunities for learning and best practices sharing, and even in a way for preparing for the shift that was about to come. Such mobilities, consisting of travel and learning opportunities, are vital in identifying and understanding your own organizational needs, to learn about new perspectives and to reflect on what can be further adapted in your organization, starting from redesigning internal policies and procedures and finishing with developing new activities, projects and partnerships.



As a response to these needs, the Leadership and Organizational Resilience in Times of Uncertainty Training Program has been implemented in the period May – September 2020 by the team of trainers Ms. Cristina Rigman, Ms. Olivia Baciu and Ms. Mirela Oprea. The Program aimed to provide a unique space for learning, reflections and thoughtful adaptation for 15 CSO leaders concerned with the disruptions in their organizations and sectors caused by the pandemic and continuous changes of the civic space. Along with the emergence of the COVID-19 pandemic, the Program represented a capacity building opportunity very much welcomed by CSO representatives from the Black Sea Region, consisting of a long-term journey on discovering ways of not just surviving, but also thriving and adjusting ways of working in challenging times.



Apart from this, in the period June – November 2020, the Capacity Building Path towards the Start-up of Regional CSO Networks Training Program took place, facilitated by Ms. Marina Sarli. The aim of the Programme was to support the members of the Black Sea NGO Forum in their process of transforming the current 14 Working Groups into thematic independent and structured regional CSO networks, by providing both strategic and operational guidance and tools to achieve common goals for developing a comprehensive three years' Working Plan. The Program provided the opportunity to design common projects and initiatives, to rethink strategic partnerships and to ensure organizational and financial sustainability.




In addition to all of these, in the context of the Black Sea NGO Forum project, at the beginning of 2020, a new **Sub-Granting Scheme for activities that support the development of CSO regional networks** has been launched. Its overall objective is to support civil society organisations part of the Black Sea NGO Forum initiate or consolidate regional thematic networks in the cooperation areas identified in the 2019 Strategic Framework, thus supporting the organisation of working meetings, seminars, workshops, trainings, research studies on thematic issues relevant for the Black Sea NGO Forum Working Groups / groups of organisations part of the Forum, as well as concrete small projects with the objective of initiating or consolidating a regional thematic network.

One of the projects implemented in the context of the Sub-Granting Scheme is "Development of WG Culture & Education via Creating Digital Tools/skills capacity and Strategic Plan", organized by International Business Development and Investment Promotion Center (Georgia), in the framework of the Black Sea NGO Forum Culture & Education Working Group. Its aim is to enhance WG structure, facilitating strategic development and internal communication through collaborative projects and initiatives. Thus, fostering the creation of regional CSO networks, in the context of the Black Sea NGO Forum, provides more long-term perspectives towards sustainable cooperation.

Key points:

- The civil society organizations and academia representatives can together promote the 2030 Agenda for Sustainable Development.
- Cross-border cooperation on transversal thematic areas creates a more e coherent results-driven framework;
- Border regions have common challenges that require common solutions and partners are adopting innovative methods of working together;
- Cross-border cooperation in the field of social economy is essential for improving policy making, and making societies more inclusive.



The process of implementing the 2030 United Nations' Agenda for Sustainable Development at national levels requires both a top-down and a bottom-up approach. In the latter approach, citizens can get directly involved and contribute to the achievement of the 17 Sustainable Development Goals (SDGs). The civil society organizations and academia can together promote and implement solutions for the

implementation of the SDGs, including in the Black Sea countries, through strong regional networks, through new innovative approaches, and tools, and more importantly, through involvement of youth in this common cause.

Cross-border cooperation is also important in tackling common challenges in the Black Sea Region, especially in what regards marine and coastal environment, marine litter and pollution. Thus, the collaboration between civil society organizations, research institutes and academia on transversal thematic areas creates a more efficient and coherent working framework, providing analytical data and linking better expertise knowledge to the society, the beneficiaries and their needs. This multi-stakeholder collaboration also ensures the delivery of more accurate results at the regional level, through digitalized processes, providing a space for coordination, sharing best practices and lessons learned.

Cross-border cooperation gains even more importance in a micro-regional context. The Danube Delta region are part of the Black Sea Region program area, therefore, collaborations in such a framework represent opportunities to strengthen regional integration, for both EU and Non-EU Black Sea countries. Such cooperation contributes to the social and economic convergence of the development of border regions that often times have common challenges that require common solutions. The COVID-19 pandemic has influenced the level and quality of cross-border cooperation, and now national authorities, together with non-governmental organizations and volunteers are adopting innovative methods of working together.

Society development comes along with multifaceted cooperation. Through cooperation, trust is being built and solutions are found in times of crisis. In the process of replicating

on large scale models of good practice and develop a functional and sustainable ecosystem in the region, cross-border cooperation in the field of social economy is essential for improving policy making, fostering social innovations, addressing regional issues and contributing to more inclusive societies.

Civil society organizations together with libraries can contribute to the development of local communities through the delivery of innovative services, to show best practices and foster the development and long-term sustainability of networks in the region.



Key points:

 Civil society organizations are relevant partners for national authorities in the monitoring and implementation of the 2030 Agenda for Sustainable Development at national levels;

- Donor organisations are open to building partnerships and dialogue with civil society organizations for national coordination and cooperation for sustainable development;
- The involvement of government agencies, of civil society organizations and of international organizations is key in promoting sustainable development at national level;
- By becoming involved in regional/ European/ international CSO networks, nongovernmental organizations can coordinate more efficiently their activities at higher levels, in order to strengthen existing development partnerships, as means for implementing the 2030 Agenda.

With a view to ensure the efficient promotion and implementation of sustainable development, a strong institutional framework is the key for good coordination for national policies in this sense. The Department for Sustainable Development has been established in 2017 under the Romanian Prime Minister office, with the main role to implement the 2030 Agenda for Sustainable Development in Romania. In order to draw on the potential capacities of all the actors involved in the process of implementing the national Sustainable Development Strategy 2030, the Department for Sustainable Development has been building multilateral partnerships, including with civil society, bringing thus into spotlight the role of NGOs in the monitoring of the Agenda at both national and European level.

This process is influenced by the particular context of each country, where the openness of the national authorities plays an important role in advancing the 2030 Agenda together with other relevant national stakeholders. **The Republic of Moldova**, as other Black Sea Region countries, is committed to the implementation of sustainable development, with successful nationalization of SDG indicators, and presenting in a very participatory manner its first Voluntary National Review at the 2020 edition of the United Nations' High Level Political Forum. In times of COVID-19 pandemic, the involvement of international organizations has fostered **national coordination and cooperation with NGOs** for sustainable development.

Thus, the involvement of government agencies, of civil society organizations and of international organizations is the key in promoting sustainable development. **Georgia** is another country where international organizations and the donor community were very active in supporting the implementation of the 2030 Agenda, together with the national NGO sector. CSOs contributed to **the strengthening of data collection and coordination processes, built the capacity of local authorities and raised the level of national public awareness** on these topics. Despite this, more consolidated cooperation is needed, in order to ensure transparency and accountability, increase representation in legislative bodies and foster public participation in policy development.

In this context, regional, European and international CSO networks become vital for dialogue, learning, and experience sharing in what regards the promotion of sustainable development. By becoming involved in these networks (such as the CSO Partnership for Development Effectiveness), CSOs at national level can coordinate more efficiently their

involvement and activities at higher levels, in high-level fora, in order to strengthen existing development partnerships, as means for implementing the 2030 Agenda.

CSO – Donor Dialogues (world-café method)

Objectives:

- ✓ Fostering the dialogue between CSOs and donors active in the Black Sea Region, with a two-fold purpose: for CSOs to learn about funding opportunities available for civil society in the Region and for donors to meet their potential grantees and learn about the needs on the ground;
- ✓ Creating a space for questions, answers, and feedback.

Starting from the very positive feedback received from the participants at the Black Sea NGO Forum on the world café sessions organised over the past few years, this session aimed at supporting an active dialogue between donors and CSOs in the Black Sea Region in what concerns funding opportunities.

Participants were given the opportunity to join one of the **4 breakout online groups**, and were encouraged to discuss together with the representative of the donor organisations about the engagement and support they provide to CSOs.

In each group, the donor "hosted" the discussions, presenting the main activities, priorities and CSO funding programs of the organisations they are representing. Following discussions, they allocated time for interaction, questions and comments.


Conclusions and acknowledgements
